Question 1: Upon physically walking the job site, the existing asphalt structure that is in place looks to be less than 2" in most places. Does Milling have to be used to demolish asphalt, or can other means be used?

Answer 1: If asphalt thickness appears to be less than 2 inches, alternate methods can be used to demolish existing asphalt.

Question 2: Upon physically walking the job site, we noticed that the area between the building and the fence is too small for any construction equipment. (Milling machine, paver, distributor, dump truck, etc.) There is no room in this area for even a truck to get turned around to back down. There is no way a milling machine can be used in this area, or getting a distributor back for the hose to reach to spray the tack coat before paving.

Answer 2: The area in question varies in width from a minimum of 6 feet to 8+ feet wide. There are means and methods available to accomplish the work in this area and the Base expects this area to be milled/demolished 2 inches and repaved by the contractor.
